Undergraduate Council September 15, 2020

The Undergraduate Council met via video conference call at 1:40pm. Action Items:

- 1. Dr. Frederickson, on behalf of subcommittee one, made a motion to recommend approval of two new course proposals from the Department of Art & Design: **ART 3345**Printmaking III and **ART 3346** Printmaking IV. It was noted that the subject prefix is not new as indicated and that the prerequisites are the same for both courses because the courses are not sequential. Dr. Kim seconded the motion. Motion passed, all in favor.
- 2. Dr. Frederickson, on behalf of subcommittee one, made a motion to table action item #3, a proposal from the Department of Economics, Finance, Insurance & Risk Management for a **new minor program in Financial Services**, until the October meeting. Ms. Cramer seconded the motion. Dr. Downey amended the motion with a request that we not delay but instead review the proposal and vote electronically before the October meeting. Discussion ensued. The motion to table the action item was approved, all in favor.
- 3. Dr. Jordan, on behalf of subcommittee two, made a motion to recommend approval of a proposal from the Department of Economics, Finance, Insurance & Risk Management to clarify the math requirements for the BS Economics major: one math course (MATH 1395, MATH 1491 or MATH 1496) and one statistics course (QMTH 2330, MATH 2311, SOC 2321, PSYC 2330, or PSCI 2312). Dr. Gillaspy seconded the motion. Motion passed, all in favor.
- 4. Dr. Jordan, on behalf of subcommittee two, made a motion to recommend approval of two proposals from the Department of Marketing and Management to update bulletin descriptions and change the credit values on the following two courses: from MGMT 3382 to MGMT 3V82 Internship in Management and MGMT 4382 to MGMT 4V82 Internship in Management. Dr. Frederickson seconded the motion. Motion passed, all in favor.

- 5. Dr. Downey, on behalf of subcommittee three, made a motion to recommend approval of two proposals from the Department of Marketing and Management to update bulletin descriptions and change the credit values on the following two courses: from MKTG 3382 to MKTG 3V82 Internship in Marketing and MKTG 4382 to MKTG 4V82 Internship in Marketing. Dr. Jordan seconded the motion. Motion passed, all in favor.
- 6. Dr. Downey, on behalf of subcommittee three, made a motion to recommend approval of a proposal from the Office of the Provost to change the monthly meeting day of the Undergraduate Council from the third Tuesday to the first Thursday of each month. Dr. Jordan seconded the motion. The proposal will be recommended to the Faculty Senate and the Faculty Handbook committee. Motion passed, all in favor.
